Non-Renewed Licenses for 2013 are now Lapsed

All CPA licenses expire each year on December 31st. Any license that was not renewed for 2013 has now lapsed, as of April 1, 2013. Any licensee who allowed their license to lapse must submit an application for reinstatement or surrender their Arkansas wall certificate, as they are no longer considered licensed in the state of Arkansas. Quality Review Surveys to be Mailed Soon

In the next few months, we will be mailing Quality Review surveys to those individuals and firms that are on the 2013 Quality Review cycle. The purpose of the QR program is to improve the quality of financial reporting and to assure that the public can rely on the fairness of presentation of financial information on which licensees issue reports.

Every Arkansas licensee (active, inactive, and firm) is surveyed once every three years.

Again, this year, those who have not issued any reports during the past year can respond as such through our website. Hopefully, this will make the surveys more convenient for those of you who do not issue any reports and help ensure that our licensees respond in a timely manner.

Be sure to respond to the survey when you receive it—each year we have several licensees who end up paying costly fines and penalties, simply because they failed to respond to the survey. Can I practice outside of Arkansas under Mobility?

A majority of states have now adopted mobility legislation – a practice privilege that generally allows a licensed CPA in good standing from a substantially equivalent state to practice outside of his or her principal place of business without obtaining another CPA license.

But how do you know if mobility applies to the services you are providing in the state that you are providing them? The CPAmobility.org website will help answer that question.

In four clicks, CPAs can find out whether or not their existing home state registration is mobile and allows them to work in other jurisdictions without additional notice or licensure.

Simply select your principal place of business; select the target state (the jurisdiction in which you will be performing services in person, by mail, by telephone or electronic means); and the type of services you will perform; and click submit.

The website will show the individual and firm requirements and will provide details on the target state’s practice privilege requirements, as well as contact information for the appropriate board of accountancy.

Comment Period For Rule Changes Ends April 19

The Arkansas State Board of Public Accountancy is proposing changes to its Rules. A public hearing for comment will be held on April 26, 2013 at 9 am in the Board office. Written comments may also be submitted via e-mail to asbpa@arkansas.gov.

Some of the more significant changes are discussed below.

Continuing Professional Education (Rule 13)

Changes to our CPE rules are being proposed to simplify the CPE requirements. Effective January 1, 2014, active licensees will be required to obtain at least 20 hours per year of the total of 40 required (60 hours over the past 3 years if using the three year look back provision) in the content areas of accounting/auditing, accounting ethics, or tax. Currently, active licensees are required to obtain at least 24 hours per year (72 hours over the past three years if using the three year look back provision) of accounting/auditing, accounting ethics, tax, computer science, or management advisory services.

Inactive Retired Status (Rule 13)

Currently, licensees who are 65 years of age or over and who do not practice accounting may change their license status to Inactive/Retired, which does not require any CPE but does require annual registration and payment of a \$30 annual fee. The proposed rule change would allow truly retired CPAs (those who represent to the Board that they do not intend to receive in the future any earned compensation for personal services) to apply for Retired status with the Board. This status would not require CPE hours or annual registration / payment of fees.

CPA Exam

All Arkansas CPA exam candidates currently must have 150 hours of college credits to sit for the CPA exam. Our board noticed recently that we were in the minority of states that require 150 hours for the exam, although almost all states required 150 hours for Licensure. If this rule change becomes effective, candidates will be able to sit for the CPA exam after completing a bachelor's degree and meeting the accounting and business content requirements (30 hours of upper level accounting and 30 business hours). Successful CPA exam candidates will be required to complete their 150 hours of education and apply for licensure within 3 years of passing the final section of the CPA exam.

Update to Arkansas Accountancy Law Signed into Law February 19th

Governor Mike Beebe signed House Bill 1121 and House Bill 1122 into law on February 19, 2013. These bills are now Act 89 and Act 90 of 2013.

HB 1121 increases the stipend payments to members of the Arkansas State Board of Accountancy from \$60 to \$110 per meeting. The revised stipend amount is consistent with other professional boards, such as the Arkansas State Medical Board, Arkansas State Board of Nursing, and the Arkansas State Board of Pharmacy.

HB1122 was drafted to accomplish the following:

- Increase the maximum fine per violation of the Accountancy laws from \$1,000 to \$10,000 plus investigation costs;
- Add Agreed Upon Procedures Reports to our Quality Review program;
- Remove obsolete and outdated language and add definitions for clarity, and;
- Clarify what types of accounting firm names may and may not be used, consistent with the Uniform Accountancy Act.

2013 Board Disciplinary Actions

The following cases were closed at the January 11, 2013 Board meeting:

- C12-068** – An unlicensed firm was using the “accounting” title. The firm has changed its signage to read “bookkeeping,” and no further action was taken.
- C12-077** – An inactive CPA was employed in public accounting. The complaint was resolved via a compliance statement. The licensee paid a \$200 penalty and is upgrading to an active license.
- C12-083** – An Inactive CPA was employed in public accounting. The complaint was resolved via a compliance statement. The licensee paid a \$200 penalty and is upgrading to an active license.
- C12-086** – An Inactive CPA was employed in public accounting. The complaint was resolved via a compliance statement. The licensee paid a \$200 penalty and is upgrading to an active license.
- C09-015** – A former licensee requested reinstatement, as their license was void due to failure to renew the license. Licensee agreed to sign a consent order, complete at least 120 hours of CPE, undergo a background check, and pay 2002-2006 inactive fees, 2013 active license fee, and late fees totaling \$555.00.
- C11-071** – The Board discovered an unregistered firm holding out as an accounting firm in Arkansas. The licensee signed a consent order, licensed the firm with the Board, and paid a \$2,500 penalty.
- C12-005** – A licensee failed to report audit reports completed during the 2005, 2008, and 2011 Quality Review survey, which resulted in violations of ACA 17-12-601(a) and Board Rule 14. Licensee signed a consent order and paid a \$6,000 penalty.
- C12-061** – A licensee failed to meet professional standards with regard to the issuance of a review report, which resulted in violations of ACA 17-12-601(a), Rule 8.1-8.2, and the Board’s Code of Professional Conduct. Licensee signed a consent order, paid a \$6,000 penalty, and agreed to submit all future attestation reports for pre-issuance review by a qualified Arkansas CPA.
- C12-069** – The Board discovered an unlicensed firm holding out in Arkansas. The firm owner signed a consent order, agreed to register the firm and seek an Arkansas Reciprocal License, and paid a \$700 penalty.
- C12-075** – A licensee’s CPA certificate/license became void on January 1, 2012 for failure to renew. The licensee has signed a consent order, undergone a background check, and paid 2009-2011 and 2013 inactive license fees and late fees totaling \$580.
- C12-089** – A licensee’s CPA certificate/license became void on January 1, 2009 for failure to renew. The licensee has signed a consent order, undergone a background check, and paid 2006-2008 and 2013 inactive license fees totaling \$580.
- C12-010** – The board discovered a licensee holding out as a firm. The firm was not registered with the Arkansas Secretary of State or the Board. This resulted in violations of ACA 17-12-401, 17-12-404, and the Board’s Code of Professional Conduct. The licensee has agreed to cease holding out as a firm, sign a consent order, and pay a \$1,000 penalty.

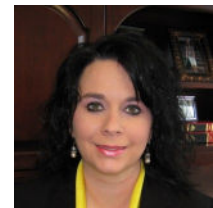

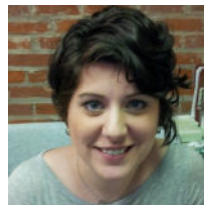

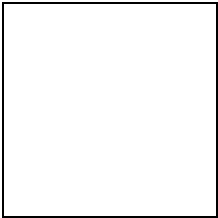
