
ORDER OF PERMANENT INJUNCTION

This cause comes before the Court this day upon the pleadings. The Court finds that the defendant, Bobby J. Bramlett, admits indebtedness to the plaintiff and consents to entry of this judgment in the amount of \$6,416.67 and consents to entry of this order of permanent injunction.

The defendant, Bobby J. Bramlett, shall prepare a schedule, verified by affidavit, of all property, both real and personal, including moneys, bank accounts, rights, credits, and chooses in action held by itself or others for it and specify the particular property claimed as exempt under the provisions of the law. The schedule shall be filed with the Court within forty-five (45) days of entry of this final judgment order.

IT IS THEREFORE CONSIDERED ORDERED AND ADJUDGED that the plaintiff have judgment and recover from the defendant, Bobby J. Bramlett, the sum of Six Thousand Four Hundred and 67 /100ths (\$6,416.67) together with costs, and interest on the principal at the rate of 8% per annum for which garnishment, attachment, and execution may issue.

IT IS FURTHER ORDERED that Bobby J. Bramlett is hereby permanently enjoined and restrained from performing electrical work in Arkansas without a license issued by the Board of Electrical Examiners pursuant to Ark. Code Ann. §§ 17-28-101 through -311.



ORDER

On the 17th day of November, 2009, this matter comes before the Board of Electrical Examiners of the State of Arkansas. Denise P. Oxley, General Counsel, Department of Labor, represented the department. Robert Gaut appeared. The Board makes the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT:

1. On July 28, 2009, the Arkansas Department of Labor (ADL) issued a civil money penalty in the amount of \$250.00 to Robert Gaut for performing electrical work without a license on a new building known as the Patterson Masonic Lodge #111, 1968 Hwy 16 E., Clinton, Arkansas.

2. The Patterson Masonic Lodge #111 was built with volunteer labor and Robert Gaut was in charge of the project.

3. Robert Gaut represented the Patterson Masonic Lodge #111 in dealings with the ADL's electrical inspector, Tracy Dolan.

4. On July 15, 2009, Robert Gaut sent an email to Tracy Dolan which reads, in part:
"After your inspection this morning you said that all of the violations had been corrected but you shown [sic] some concern on the #6 copper ground wire on the utility pole. I purchased an 8' steel, copper clad ground rod and drove it in the ground and attached a #4 ground wire from the

meter panel to the ground rod, I also left the #6 ground intact." This work constitutes electrical work within the meaning of Ark. Code Ann. § 17-28-101(4).

5. Earlier, by email of July 7, 2009, Robert Gaut advised Inspector Dolan that "We" had completed the list of discrepancies Inspector Dolan had noted. Specifically, Mr. Gaut notes:

#1 #4 ground wire from meter to inside panel. The wiring was removed from the meter to the inside CB panel on Monday 6, July, 2009, and a #2 copper ground wire was added and the wires pulled back in. . .

#2 Special rated fan boxes for the overhead ceiling fans. These boxes have been replaced with fan rated boxes and the boxes properly grounded.

#3 Staples for romex, all of the romex wiring has been stapled to the studs. . .

#4 #4 copper ground wire for copper water lines. A #4 copper wire has been installed to both the cold and hot water copper fittings just behind the valves at the hot water heater and terminated on the grounding strip in the CB Panel.

#5 #6 copper ground wire from ground strip in CB Panel to rebar grounding grid and footings. The #6 copper ground wire was replaced with a #4 copper wire and the connection for the #4 wire to rebar was terminated in a 4x4 access for easy inspection.

#6 Clamp type bushings have been installed in the CB panel to prevent chafing of the wiring.

#7 The green screw was terminated to the CB Panel on the grounding strip.

#8 Three outlets have been installed for temporary power, two in the mechanical room and one in a closet, all three are 15A GFI.

6. Mr. Gaut further noted in his July 7, 2009 email, "You are welcome to come back at any time to inspect the repairs and the wiring, we are usually on site between 8am and noon during the week. . .because most of the volunteer labor is senior citizen members of the lodge."

7. Robert Gaut has refused to tell Inspector Dolan, as well as this board, who did the primary electrical installation on this project, other than the work referenced in paragraph 4 above.

8. Robert Gaut was and is not licensed as an electrician in Arkansas.

CONCLUSIONS OF LAW:

9 Ark. Code Ann. § 17-28-304 (Repl. 2001) provides that "No person shall perform electrical work in this state. . .unless the person has first obtained a license. . ."

10. Ark. Code Ann. § 17-28-309(b) authorizes the Director of the Department of Labor to assess a civil penalty against any person, subject to appeal and hearing before the Board, for violations of Ark. Code Ann. § 17-28-304, among other things.

11. While the Board can not conclude that Robert Gaut performed most of the electrical work on the Patterson Masonic Lodge #111, the evidence is clear that he performed some of the electrical work. The work he admitted performing constitutes "electrical work" within the meaning of the statute and the Board's regulations. Ark. Code Ann. § 17-28-101(4) and Board of Electrical Examiners Rule 010.13-009(F).

12. In his defense, Robert Gaut contends that he was actually charged with "performing work as a contractor" and that he is not a contractor because he is not in business; did not charge any fee for his work; and was doing volunteer work for a non-profit entity. Mr. Gaut points to a document contained in the investigative file which is entitled "Civil Penalty Summary Report" and does, indeed, state that this case involved a \$250.00 fine for a first offense of "Performing work as a contractor".

13. An electrical contractor's license is not mandatory and would thus not result in the imposition of a fine. *See* Ark. Code Ann. § 17-28-302.

14. Robert Gaut was properly notified of the charge against him.

a. The "Notice of Violation and Fine Assessment" sent to him on July 28, 2009, by certified mail stated that he was charged with "1 violation(s) of the State Electrical Code and/or state law governing the licensing of electricians." *See* Agency Exhibit No. 3.

b. The "Notice of Hearing" sent by certified mail on August 25, 2009, stated that "the Department of Labor charged Robert Gaut with one (1) license violation." *See* Agency Exhibit No. 1.

c. Approximately one (1) month prior to the hearing, counsel for the Department of Labor sent Mr. Gaut a letter responding to various inquiries which further emphasized the department's position. "You sent Mr. Dolan an email stating that you had personally corrected some of the electrical violations. This is performing electrical work without a license and is illegal in Arkansas." *See* Agency Exhibit No. 8.

IT IS THEREFORE ORDERED that the civil money penalty assessed by the Director of the Department of Labor against Robert Gaut in the amount of \$250.00 is affirmed.
