





**ORDER**

On the 20<sup>th</sup> day of November 2012, this matter comes before the Board of Electrical Examiners of the State of Arkansas. John Young failed to appear after being duly notified. Denise P. Oxley, Chief Legal Counsel, Department of Labor, represented the department. The Board makes the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT:**

1. John Young is a master electrician licensed by the Board of Electrical Examiners with master license number M-5515.
2. On December 21, 2011, Charles Covington, Chief Electrical Inspector of the Department of Labor performed an electrical inspection at the Cabot Nursing & Rehabilitation project at 121 Spring Valley, Cabot, Arkansas.
3. Mr. Covington observed three (3) individuals performing electrical work on the project who did not have an Arkansas electrician's license. Two individuals, Johnny Holeman and Alfred Holeman, were from Oklahoma. The third individual, Matt Payne, had an expired apprentice license for Arkansas, EA-6940.
4. All three (3) individuals advised Mr. Covington that they were employees of Montgomery and Sons Construction, Inc., the electrical contractor on the project.

5. John Young served as the master electrician qualifier for Montgomery and Sons Construction, Inc. with the Contractor's Licensing Board from April 5, 2010 to April 20, 2012.

6. As a result of this inspection, the Department of Labor issued a civil money penalty to John Young in the amount of \$2,250.00 for employing three (3) unlicensed persons in violation of Board Rule 010.13-017(F).

7. Prior to this assessment of a penalty, the department had assessed John Young a civil money penalty on September 23, 2011, for employing one unlicensed person on the same project in violation of Board Rule 010.13-017(F). Montgomery and Sons Construction, Inc. paid that fine of \$75.00.

8. On April 25, 2012, the department received a request for hearing from John Young.

9. This matter was originally set for hearing on July 17, 2012. Mr. Young requested a continuance and the matter was rescheduled for November 20, 2012. Notice was mailed to Mr. Young at his address of record.

#### **CONCLUSIONS OF LAW:**

1. Ark. Code Ann. § 17-28-304 (Repl. 2001) prohibits any person from performing electrical work in Arkansas without a license.

2. Ark. Code Ann. § 20-31-104 (Repl 2005) authorizes the Board of Electrical Examiners to adopt minimum standards for the performance of electrical work. The Board has adopted Rule 010.13-017(F), which provides "No person licensed by this Board shall employ unlicensed persons or unregistered apprentices to perform electrical work. . ."

3. Ark. Code Ann. § 17-28-309(b) authorizes the Director of the Department of Labor to assess a civil penalty against any person, subject to appeal and hearing before the

Board, for violations of Ark. Code Ann. § 17-28-304; for violations of the Arkansas Electrical Code Authority Act, Ark. Code Ann. §§ 20-31-101 *et seq.*; and for violations of any regulation promulgated by the Board.

4. The Board concludes that John Young violated Rule 010.13-017 as promulgated by the Board.

IT IS THEREFORE ORDERED that the civil money penalty assessed by the Director of the Department of Labor against John Young in the amount of \$2,250.00 is affirmed.







This violation occurred on January 24, 2013 at 237 Tanglewood, A5, Lake Hamilton, Arkansas. Stoney Lane did not contest the penalty, but tendered payment on or about September 26, 2013.

CONCLUSIONS OF LAW:

The Arkansas Department of Labor is authorized to assess this civil money penalty pursuant to the provisions of Ark. Code Ann. § 17-28-309(b).

THEREFORE, the civil money penalty is finalized in the amount of \$50.00, there being no appeal to the Board of Electrical Examiners.


