# OSHA AND COVID-19

- **Mask requirements**
  - **When using a N-95 mask, a company is required to follow the 1910.134 respirator standard**
- **When should companies record COVID-19 illnesses on the OSHA 300 log?**
  - **When multiple workers from the establishment contract COVID-19**
  - **If it is later determined that it was from the community, mark through the recording on the log.**

# FATALITIES

## CLOSED CASE FATALITIES

**Not Work-Related:** Heart Attack

**Caught-in / Between:** The deceased was found crushed underneath the trailer he was unloading.

**Not Work-Related:** The truck was on an incline. The wheels had not been chocked and the truck was idling. The victim was found unresponsive pinned under the trailer's wheels.

**Fall:** Employee fell from top of a ladder, approximately 102 inches

**Other (Respiratory Failure):** The victim experienced respiratory distress and radioed the Plant Manager. No first aid was administered to the victim prior to transport to the hospital. The Plant Manager drove The victim to the Great River Medical Center. Approximately 8 minutes before arrival the victim stopped breathing.

**Electrocution:** Employee came into contact with 480volts of electricity

# FATALITIES

## CLOSED CASE FATALITIES CONTINUED

**Caught-in / Between:** While the mobile home was on jack stands, which were on rollers, the home shifted and fell from the stands. This caught the employee under a portion of the structure, causing him to suffocate.

**Electrocution:** Insulator on the pole failed as the employee grabbed the anchor point and an arc from the pole traveled to the guide wire, down to the employee, and into the ground.

**Fall:** Boom of aerial lift broke causing the platform to fall approximately 17ft

**Caught-in / Between:** When the employer had not seen Employee #1 in a while, he and Employee #2 went looking for Employee #1. Employee #1's body was recovered at approximately 4 pm by first responders.

- **Not discriminate against workers who exercise their rights under the ACT (Section 11(c))**
- **Post OSHA citations and abatement verification notices**
- **Provide and Pay for PPE**



# RESPONSIBILITIES OF THE EMPLOYER

- **Provide a workplace free from recognized hazards and comply with OSHA standards**
- **Provide training required by OSHA standards**
- **Keep records of injuries and illnesses**
- **Provide medical exams when required by OSHA standards and provide workers access to their exposure and medical records**



# OSHA COMPLAINTS

- **Non-Formal/Phone & Fax**
  - **Not signed**
  - **Ex-employee**
  - **Not an employee**
  - **Anonymous**
  - **Processed within one (1) day**
  - **Employer has five (5) days to respond**
  - **Can be elevated to on-site inspection**
- **Formal**
  - **Signed by a current employee or their representative**
  - **On-site inspection within five (5) days**

# THE RIGHT TO FILE A COMPLAINT

- **Workers may file a complaint with OSHA if they believe a violation of a safety or health standard, or an imminent danger situation, exists in the workplace.**
- **Workers may request that their name not be revealed to the employer.**
- **If a worker files a complaint, they have the right to find out OSHA's action on the complaint and request a review if an inspection is not made.**
