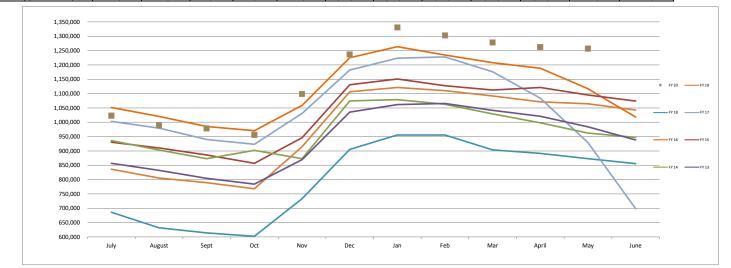

# The Board Rule for Arkansas State Board of Licensure for Professional Engineers and Professional Surveyors Department of Labor and Licensing

### **Summary of Public Comment and Agency Response**

1. Comments of Randy Johnson, E.I.; Kiron Browning, P.E.; John Campbell, P.E.; Dwayne Calhoun, P.E.; Sam Paulus, P.S.; John Harty, P.E.; and Rick Nichols, P.E. were regarding the deleting of character requirements such as "good moral character" and "moral turpitude".

Agency Response. The character requirements such as "good moral character" and "moral turpitude" were deleted from the Board's Rules pursuant to Act 910 of 2019. Rules of the Board, Article 20. Ethics and Rules of Professional Conduct did not contain such character requirements; therefore, no requirements were deleted from this article.

#### Board Response.

2. Comment of John Campbell, P.E. was to add "webinars" to the PDH credits.

Agency Response. Article 19 Continuing Professional Competency (CPC) D.1.d, D.2.d, lists seminars as a qualifying unit for PDHs.

#### **Board Response.**

3. Comment of Kiron Browning, P.E. was wanting clarification of amending reciprocity/comity requirements for all applicants who hold substantially similar licenses.

Agency Response. Board Staff sent the mark-up copy of the rule to Browning for review. The amendments to the current rule regarding reciprocity/comity licensure was pursuant to Act 1011 of 2019.

#### Board Response.

4. Comment of Kiron Browning, P.E. was wanting clarification of amending the temporary license.

Agency Response. Board Staff sent the mark-up copy of the rule to Browning for review. The amendments to the current rule regarding temporary licensure was pursuant to Act 1011 of 2019 and Act 426 of 2019.

#### Board Response.

5. Comment of Kiron Browning, P.E. was wanting clarification of amending the rule regarding members of the military and their spouses to include expedited licensure for Professional Surveyor applicants and automatic licensure for Professional Engineers, Engineer Intern, and Surveyor Intern applicants.

Agency Response. Board Staff sent the mark-up copy of the rule to Browning for review. The amendments to the current rule regarding the members of the military and their spouses was pursuant to Act 820 of 2019. Article 8.I Military Licensure rule was approved by the Legislative Administrative Rule Subcommittee on May 14, 2020.

#### Board Response.

6. Comment of "Trey" Roy Lee Lewis, S.I. was seeking clarification regarding if the applicant will be required to get board permission or if the applicant can register without permission from the board for the NCEES Principles and Practice exam.

Agency Response. The Director stated in an email to Lewis that "the proposed rule in section d. that you mention below (in email) gives the future applicant a choice whether they can request approval/permission to take the NCEES Professional Survey Exam (current rule) or the applicant may take and pass the exam without approval/permission and apply for licensure once they pass the exam. If you choose to take the NCEES exam prior to submitting the PS application, there is no approval by the Board for exam registration; therefore, you may take it before your experience is gained. The Board will not issue the PS license until all qualifications are met including passing of the NCEES PS exam, education and experience. The Professional Surveyor applicant will still need Board approval/permission through the licensure process to take the AR State Specific Exam and once passed receive licensure."

#### Board Response.

7. Comment of Sam Paulus, P.S. was seeking clarification regarding the "removal of college requirements for original applicants.".

Agency Response. The Director stated in an email to Paulus that "I am in receipt of your email below and will attempt to answer any questions. In 2017, the Board hired an expert

to conduct a study of the specific courses and credit hours required to complete the education qualifications which were promulgated in 2008. The study of several universities and colleges found that many of the required courses were not being offered and some new courses with updated credits were being offered. The Board decided that the education qualification is still 30 hours of surveying courses with "One or more of the courses shall emphasize Public Land Survey System aspects and principles, and one or more of the courses shall emphasize :Law and Professionalism in Geomatics or Surveying." (Proposed ROB Article 8.D.1.c and Article 8.E.1.a.iii).."

#### Board Response.

8. Comment of Joe McGartland, P.E. was removing the social security number (SSN) from the applications.

Agency Response. The SSN is required pursuant to Federal Law (the Social Security Act section 466(a)(13)), and State Law (A.C.A. §17-1-1 04(a)) disclosure of the Social Security Number (SSN) is mandatory and will be used under the child support enforcement program.

#### Board Response.

9. Comment of John Harty, P.E. was the Director should not "approve licensure at his discretion" and he gives "no credence to the qualifying statements regarding Board ratification and "qualified applicants." To allow one person to wield that kind of power is to invite corruption and public endangerment."

Agency Response. Board Policy from 1998 to present allows the Director to Conditionally Approve qualified Professional Engineer-Comity applicants who meet the Arkansas Model Law Engineer (MLE) qualifications (education, exams, experience, enforcement) prior to Board ratification. In 2008, the Board Policy extended to qualified Engineer Interns and COA licensure. Original licensure applicants are not Conditionally Approved. The Board determined that the long-standing policy needs to be a board rule. The new rule is as follows: Article 8.A.4 The Board authorizes the Director to conditionally approve, subject to Board ratification, all comity and intern applicants who meet the requirements of the Board's statutes and rules.

#### Board Response.

10. Comment of Leland Dyson, P.E. Arkansas State Engineer "Thanks for your efforts related to the transformation of our state government. After reviewing the proposed

amendments to the Rules of the Board, I noticed a couple of Articles within the proposed changes that may warrant clarifications. Article 12 "CERTIFICATES AND SEALS", paragraph B(1)(a) now indicates that the Professional Engineer's seal is no longer required on the drawing cover sheets of final engineering drawings. Article 12, paragraph B(3) also now implies that only the Certificate of Authorization (COA) is to appear on the cover sheet of plans, whereas both the engineer's seal and the COA have been required in the past. My concern is that the rule changes do not fully address seals on the cover sheet of drawings, and thus establish Responsible Charge, by two classes: (1) sole proprietorship firms and (2) State government agencies whom produce design documents with in-house engineering staff. Sole proprietor engineers are specifically exempted in the rule changes from requiring a COA per Article 8 "GENERAL REQUIREMENTS FOR LICENSURE", paragraph G(1)(c). State government agencies are not specifically exempted in the rule changes but may be exempt by State statute. Nonetheless, as written, it appears that neither class of engineers (sole proprietors or government agencies) are required to seal the cover sheets of drawings, and thereby establish Responsible Charge. I might suggest that clarification be made within the rule changes for the individual engineer's seal to be attached to the cover sheet of engineering drawings for these two classes of engineers, in order to establish Responsible Charge. Please consider possible clarification for this important issue."

Agency Response. In an effort to clarify the Certificates and Seals rule, staff recommends removing the language in parentheses in Article 12.B.1.a "Each page of each final engineering document to include drawings (but not including the drawings cover sheet), and the cover sheet of each volume of specifications and the signature page of written reports prepared by a licensee shall, when issued, be dated, signed and stamped with the said seal or facsimile thereof by the responsible licensee(s)."

#### Board Response.

11. Comment of Jason Waldemer, P.S. was verifying that the rule change "would require PDH's in Minimum Technical standards or standards of practice."

Agency Response. Staff sent the Legal Notice of Rulemaking to Waldemer. According to Article 19.C.2 "A professional surveyor, including a professional surveyor who is a dual licensee, is required to have at least two (2) PDH hours of Arkansas Standards of Practice No. 1 for Property Boundary Surveys and Plats for each renewal period."
