

Arkansas State Board of Licensure
for Professional Engineers and Professional Surveyors
Minutes – November 8, 2022

A meeting of The Board was convened at 10:00 am in the Board Room at 623 Woodlane Dr., Little Rock, Arkansas by Lorie Tudor, President. Members present Murry Cline, Donald Perry, Brian Moore (via ZOOM), Tom Scott, and Rod Williams (via ZOOM). Absent Members Ivan Hoffman, David Beasley, and Kyle Salyer. Others present; Director Heather Richardson, Chief Investigator Grant Grigg, Assistant Director, Linda Stone (via ZOOM), Agency Counsel Joe West, Attorney General's Office.

President Tudor noted a quorum was present and turned the meeting over to Charlie Moulton, Administrative Hearing Officer for the matter of Case #2021-09, in the matter of Board v Respondent Justin Hall, PE 11050 & Hall Engineering LTD, COA 982. Administrative Hearing attendees included: Agency Counsel Joe West, Assistant Attorney General's Office, Charlie Moulton, Hearing Officer, Jennifer Barnett Court Reporter, Respondent Justin Hall, PE, and his Counsel Harrison Kemp. Other parties attending: Rachael McKenzie and Mariel Henderson (AR Attorney General's Office), Jim Driedric (Property Services Manager Catholic Diocese Little Rock), Diane Campbell (Secretary All Saints Catholic Church), and Jacques Pierini, PE.

After testimony by all parties the Board went off-the-record to deliberate. Back on-the-record, Williams, Tudor, Scott recused themselves. Motion was made (Cline moved, Perry seconded) and carried that:

- The Allegations of Fact 1-8 and 10-12 are proven true and Mr. Hall is ordered to pay a \$2,000 civil penalty for the violation stated in Paragraph 12 and a \$4,000 civil penalty for the violation stated in Paragraph 13. Further, his license is suspended for a period of four (4) months. Closing instructions were provided and the Hearing ended at 3:10 pm.




