

2023 Open Class Schedule

Arkansas Department of Labor & Licensing, Arkansas State Grants, MSHA Section

A primary emphasis of the Arkansas State Grants Mine Safety and Health program is to provide training opportunities for surface metal/nonmetal miners and contractors. All classes are taught in English with no provisions made for interpreters.

Payment Policy: The fee is \$40.00 per person for the one-day annual refresher and \$80.00 per person for the two-day new miner class. Once we verify your employees are attending the class, we will contact you by phone and have you pay for their attendance (typically the day of class). Payment by credit/debit card or bank account are the methods of payment available.

We can conduct training classes at your facility: In addition to the dates in this flyer we can provide on-site training at your location for Annual refresher, Partial New Miner, First aid and CPR. However, we will require payment for at least 5 attendees per class. If you have less than 5 attendees, please take advantage of our open classes.
