PRESIDENT VENABLE'S REMARKS

Since the last newsletter, the Board has met twice. A meeting was held on December 6, 1991 on the campus of Arkansas State University. We had a very productive meeting and we appreciate the hospitality shown to the Board by Dr. Al Mink and his staff at A.S.U.

A committee was appointed to revise the forms now used by applicants for registration, and this committee has been working toward having this revised application available in the very near future.

The last meeting of the Board was held on February 28. At this meeting, Mr. Gary Whitfield — PLS #882, whose license was suspended for one (1) year at the September Disciplinary hearing, asked that the Board review his suspension and, if possible, terminate the suspension order. The board voted to do so and terminated the suspension order as of March 1, 1992. Mr. Whitfield is to remain on probation until March 1, 1993, and was ordered to furnish copies of all of his surveys within that time frame to the Board. The submission to the Board would not relieve Mr. Whitfield from filing with the County or State Surveyors Office.

Two other complaints were discussed and hearings have been scheduled for the May 28 Board Meeting.

Final plan preparations are under way for the Southern Zone Meeting to be held in Hot Springs on April 2, 3, & 4. We expect to have approximately 100 board members for the various southern states in attendance. Board member Walt Lefevre, the present Southern Zone Vice President, will chair this meeting.

We also lost one of our board members in January.

Maribeth Frazer, who was serving as the Consumer Representative, has been appointed by Governor Clinton to serve on the State Board of Education, and has resigned her position on our Board. We appreciate the service that Maribeth did while on the Board and wish her well on her new appointment.

In the meantime, we have been notified that Billy Wayne Fly of DeWitt has been named by Governor Clinton as the Consumer Representative to replace Maribeth. We welcome Billy to the Board and look forward to working with him.

We are also in the process of publishing the roster which will contain the revised rules. We hope to have this printed and distributed prior to July 1, 1992.

BOARD MEMBERS

Maribeth Frazer resigned as a Public member of the Board in February 1992. She has accepted a position as a member of the State Board of Higher Education. Maribeth was an active, valuable member of this Board and we wish her well in her new position.

Governor Bill Clinton appointed Billy Wayne Fly of DeWitt to replace Maribeth and serve the remainder of her term. Mr. Fly is a farmer in Arkansas County. We welcome him to the Board.

BOARD RULES

The Board has been busy the past year in revising the rules of the Board. A Public hearing was held in December 1991 and the new rules of the Board became effective January 16, 1992. A complete copy will be mailed to all registrants around June 1, 1992. A few of the changes you should take notice of are as follows:

1. **EXPERIENCE:** The professional experience will start after graduation. Any experience gained prior to graduation will not count toward the four (4) year requirement for the Principle & Practice exam.
2. **SEAL:** The use of the seal and the signature have been changed as follows:

C. Upon registration each registered professional engineer shall obtain a seal of the design authorized by the Board bearing the registrant's name, registration number and the legend "Registered Professional Engineer". Final engineering drawings, specifications, plans and reports prepared by a registrant shall, when issued, be dated signed and stamped with the said seal or facsimile thereof. It shall be unlawful for an engineer to affix, or permit his seal or facsimile thereof to be affixed, to any engineering drawings, specifications, plats or reports after the expiration of his registration or for the purpose of aiding or abetting any other person to evade or attempt to evade any provision of the Statutes and the Rules of the Board.

D. Upon registration each registered land surveyor shall obtain a seal of the design authorized by the Board, bearing the registrant's name, registration number and the legend "Land Surveyor". Final drawings, plats and reports prepared by a registrant shall, when issued, be dated, signed and stamped with the said seal or a facsimile thereof. Further, the land surveyor shall prepare all plats to meet or exceed the minimum standards of land surveying in Arkansas. It shall be unlawful for a registrant to affix or permit his seal and signature or facsimile thereof to be affixed to any drawings, plats or reports he did not prepare himself or supervise the preparation of or after the expiration of his registration or for aiding or abetting any other person to evade or attempt to evade any provision of the Statutes and Rules of the Board.

3. **EXEMPTION:** The Board has established definite policies for the exemption from continuing education for Land Surveyors. The policy is as follows:

G. Exemption — A person who is older than sixty (60) years of age on/or before July 1 of the year of application or who has twenty (20) years of acceptable surveying experience in Arkansas may be exempted from these continuing education requirements if he meets the following requirements:

1. Makes application for exemption on the forms furnished by the Board.
2. Includes the endorsement of three (3) registered land surveyors who have personal knowledge of his surveying work.
3. Exhibits proof that his work complies with the laws of the State of Arkansas and meets

the Minimum Standards as established by the state surveyor's office including the filing for record of his survey plats with the county clerk and the state surveyor's office.

4. Passes the Arkansas state specific examination that is administered as part of the Principles and Practices process for original registration as of January 1, 1992 in the State of Arkansas.
5. If all of the above requirements are met then the applicant shall be exempt from the continuing education requirements for a period of five (5) years after which he must reapply.

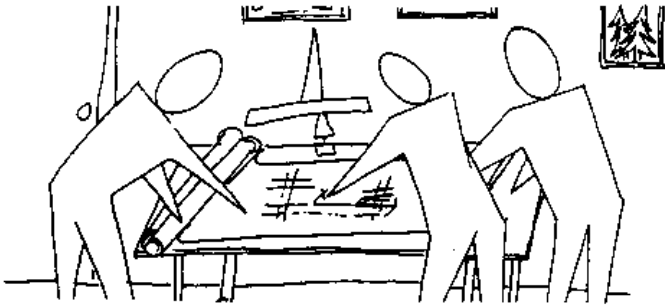
