## **OPINION AND ORDER FILED SEPTEMBER 28, 2021**

Hearing conducted before ADMINISTRATIVE LAW JUDGE TERRY DON LUCY, in Pulaski County, Arkansas.

Counsel for the Claimant: pro se.

The above-captioned matter came on for a hearing on September 22, 2021, with respect to the Respondents' Motion to Dismiss filed with the Commission on August 18, 2021. When the hall was sounded at the appointed time for the hearing, the Claimant was not present for such, nor did the Claimant appear during the ensuing proceedings. Respondents' Exhibit No. 1 was subsequently introduced into the record without objection, and the Commission's file in this matter was deemed incorporated by reference into the record without objection for purposes of this Opinion and Order.

The Commission's file reflects that notice of the Respondents' Motion was sent to the Claimant via certified and first-class mail from the Commission dated August 20, 2021, to a last known address of 425 Jefferson Street, Benton, Arkansas, 72015, and that notice of the hearing was likewise sent to the Claimant via certified and first-class mail from the Commission dated September 10, 2021, to the same last known address. The Respondents also served the present Motion upon the Claimant. The Commission's file reflects no response from the Claimant with

respect to the Respondents' pending motion and further reflects that efforts to deliver the notice of hearing by the United States' Postal Service were apparently unsuccessful.

The Commission's file and Respondents' Exhibit No. 1 further reflect that the Claimant filed a hearing request in this matter on April 13, 2018. Such request resulted in a mediation effort that was unsuccessful. Consequently, this matter was returned to the Commission's general files on June 15, 2018. Since that date, it appears that the Claimant has taken no further action to pursue this claim.

In addition, there is no indication that the Claimant herein has responded to or otherwise objected to the Respondents' pending Motion. Finally, during the hearing, Counsel for the Respondents offered uncontradicted statements that his office had received no communication from the Claimant with respect to the Respondents' pending Motion.

Given the Claimant's lack of objection to the Respondents' Motion, corresponding failure to appear at the hearing held on September 22, 2021, and apparent failure to request a hearing on the merits of this claim since June 15, 2018, I specifically find that the Claimant has failed to prosecute this claim in a timely manner and that dismissal thereof without prejudice is warranted pursuant to Ark. Code Ann. §11-9-702 and Commission Rule 099.13, for lack of timely prosecution, and hereby grant the Respondents' Motion.

The above-captioned matter is respectfully dismissed without prejudice effective September 22, 2021, and the Respondents are ordered and directed to pay the court reporter's fee within thirty days of billing for such.
