ARKANSAS CONTRACTORS LICENSING BOARD

vs

STABRIDG CONSTRUCTION CO., INC

ORDER

The Board voted unanimously that the license of Stabridg Construction Co., Inc. is hereby revoked for misconduct. Stabridg Construction shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ORDER

The Board voted unanimously that P T R Baler & Compactor Company shall pay a civil penalty of \$677..00 for violation of Act 150; \$677.00 for violation of Act 162 on the project in Fort Smith and \$754.00 for violation of Act 150; \$754.00 for violation of Act 162 on the project in Conway as amended for a total of \$2,862.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs

ROBERT PERRY, D/B/A ADVANCED REFRIGERATION

ORDER

The Board voted unanimously that Robert Perry, d/b/a Advanced Refrigeration shall pay a civil penalty of \$4,896.00 for violation of Act 150; \$8,160.00 for violation of At 162 as amended for a total of \$13,056.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a cease and desist order be issued against Robert Perry, d/b/a Advanced Refrigeration for any work done in violations. Robert Perry, d/b/a Advanced Refrigeration shall refrain from bidding on or performing work on any

projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
