ARKANSAS CONTRACTORS LICENSING BOARD

VS

GILBERT HARVEY, D/B/A FRENCHIES CONSTRUCTION

ORDER

The Board voted unanimously that Gilbert Harvey, d/b/a Frenchies Construction shall pay a civil penalty of \$2,100.00 for violation of Act 150; \$3,500.00 for violation of Act 162 as amended for a total of \$5,600.00 to the Board, payable within twenty (20) days of receipt of this Order. The Board further ordered that a Cease and Desist Order shall be authorized against Gilbert Harvey, d/b/a Frenchies Construction should he be found working in violation in the future. Gilbert Harvey, d/b/a Frenchies Construction shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

The Board voted unanimously that the license of RL Construction of Arkansas, LLC is hereby revoked for misconduct. RL Construction of Arkansas, LLC shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
