The Board voted unanimously that David Sugarek, d/b/a J.A.R. Properties shall pay a civil penalty of \$1,890.00 for Act 150 & \$1,890.00 for Act 162 as amended for a total of \$3,780.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.
