ARKANSAS CONTRACTORS LICENSING BOARD

vs.

APEX MANAGEMENT, INC.

ORDER

The Board voted unanimously that Apex Management, Inc. shall pay a civil penalty of \$6,868.50 for violation of Act 150; \$6,868.50 for violation of Act 162 as amended for a total of \$13,737.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

ORDER

The Board voted unanimously that Ken Willis shall pay a civil penalty of \$1,710.00 for violation of Act 150; \$1710.00 for violation of Act 162 as amended for a total of \$3,420.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

The Board voted unanimously that H & H Earthwork & Landscape, LLC shall pay a civil penalty of \$6,400.65 for violation of Act 150 reduced to \$3,200.32 if licensed within 90 days; \$6,400.65 for violation of Act 162 as amended for a total of \$12,801.30 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ORDER

The Board voted unanimously that Todd Ashabranner, d/b/a Craighead County Roofing shall pay a civil penalty of \$1,106.52 for violation of Act 150 reduced by one-half if licensed within 90 days; \$1,106.52 for violation of Act 162 as amended for a total of \$2,213.04 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ORDER

The Board voted 3 to 2 that Terry Wedgeworth shall pay a civil penalty of \$211.60 for violation of Act 150; \$211.60 for violation of Act 162 as amended for a total of \$423.20 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and

obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

AMERICAN PRE-FABRICATED STRUCTURES, INC.

ORDER

The Board voted unanimously that American Pre-Fabricated Structures, Inc. shall pay a civil penalty of \$400.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

BOATRIGHT COMPANY, INCORPORATED

ORDER

The Board voted unanimously that Boatright Company, Incorporated shall pay a civil penalty of \$500.00 for violation of Act 150 to the Board payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
