ARKANSAS CONTRACTORS LICENSING BOARD

vs

WHITE CONSTRUCTION & CONCRETE CO., INC.

ORDER

The Board voted 5 to 1 that White Construction & Concrete Co., Inc. is guilty of misconduct. The license of White Construction & Concrete Co., Inc. is hereby suspended and White Construction & Concrete Co., Inc. shall pay a civil penalty of \$500.00 to the Board payable within twenty (20) days of receipt of this Order. The Board further orders that a cease and desist order be issued to prevent White Construction & Concrete Co., Inc. from performing work in violation. White Construction & Concrete Co., Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.

AOI TELECOMMUNICATIONS, INC.

ORDER

The Board voted unanimously that AOI Telecommunications, Inc. shall pay a civil penalty of \$1,050.00 for violation of Act 150; \$1,050.00 for violation of Act 162 as amended for a total of \$2,100.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*

WORLD CLASS ROOFING & CONSTRUCTION, INC.

ORDER

The Board voted 5 to 1 that World Class Roofing & Construction, Inc. is guilty of misconduct and fraud or deceit in obtaining a license. The license of World Class Roofing & Construction, Inc. is hereby suspended and World Class Roofing & Construction, Inc. shall pay a civil penalty of \$500.00 to the Board payable within twenty (20) days of receipt of this Order. The Board further orders that a cease and desist order be issued to prevent World Class Roofing & Construction, Inc. from performing work in violation. World Class Roofing & Construction, Inc. shall refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board.
