ORDER

The Board voted unanimously that Rob Richens, d/b/a Richens Concrete Inc. shall pay a civil penalty of \$2,736.00 for violation of Act 150; \$9,120.00 for violation of Act 162 as amended for a total of \$11,856.00 to the Board, payable within twenty (20) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*
