ARKANSAS CONTRACTORS LICENSING BOARD

vs.

DATACOM SYSTEMS, LLC.

ORDER

The Board voted unanimously that Datacom Systems, LLC shall pay a civil penalty of \$200.00 for violation of Act 150; \$200.00 for violation of Act 162 as amended for a total of \$400.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

WAYNE BRYANT, D/B/A QUALITY RESTORATION

ORDER

The Board voted unanimously that Wayne Bryant, d/b/a Quality Restoration shall pay a civil penalty of \$1,383.76 for violation of Act 150; \$1,383.76 for violation of Act 162 as amended for a total of \$2,767.52 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

STEIN STEEL & SUPPLY COMPANY

ORDER

The Board voted unanimously that Stein Steel & Supply Company shall pay a civil penalty of \$500.00 for violation of Act 150; \$500.00 for violation of Act 162 as amended for a total of \$1,000.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

ARKANSAS CONTRACTORS LICENSING BOARD

vs.

RUBEN RODRIGUEZ, D/B/A RODRIGUEZ CONSTRUCTION CO.

ORDER

The Board voted unanimously that Ruben Rodriguez, d/b/a Rodriguez Construction Co. shall pay a civil penalty of \$744.00 for violation of Act 150 reduced by 1/2 if licensed within 90 days; and a violation of Act 162 but assessed no penalty as amended for a total of \$744.00 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.

MICHAEL MOORE, D/B/A EXTERIORS, INC.

ORDER

The Board voted unanimously that Michael Moore, d/b/a Exteriors, Inc. shall pay a civil penalty of \$1,412.79 for violation of Act 150; \$2,354.65 for violation of Act 162 as amended for a total of \$3,767.44 to the Board, payable within five (5) days of receipt of this Order and refrain from bidding on or

performing work on any projects in excess of \$20,000.00 prior to being licensed with the Contractors Licensing Board and obtaining a \$10,000.00 surety bond or cash bond as required by Ark. Code Ann. § 17-25-401, *et seq.*.
