**DISMISSAL ORDER**

The Arkansas Board of Licensure for Professional Engineers and Professional Surveyors (hereinafter "the Board") registered a complaint on August 20, 2010, charging Raymond Hickey (AR-PS #903, hereinafter "Hickey") with negligence and/or incompetence in the practice of surveying, in violation of Arkansas Code Annotated §17-48-102(b)(1)(A)(2).

**FINDINGS OF FACT**

1. Hickey is a Professional Surveyor licensee of the Board, and the Board has jurisdiction over his conduct.
2. Hickey was retained to survey and set monuments where necessary for land owned by the Lakeview Country Club (Club).
3. Gary Wimberly holds a parcel of land adjoining the Club and he brought a complaint against Hickey for negligence and/or incompetence because he believed that Hickey improperly set a boundary corner between his land and the Club.
4. Upon investigation, the Board found no evidence of negligence or misconduct by Hickey.


**CONCLUSIONS OF LAW**


**APPEALS**
