## August 16, 2017

The regularly scheduled meeting of the Arkansas Motor Vehicle Commission was called to order at 9:30 a.m. by Chairman Joy Blankenship. Staff present included Kristi Byers, Tanelle Hymes and Robert Galloway. All Commissioners were present during the meeting with the exception of Mitchell Ward. Also in attendance were Greg Kirkpatrick with AADA, Sandy Stroope, Dennis Mickels as the court reporter, Charlie Moulten as the hearing officer, and Julie Chavis with the Attorney General's Office.
