You can also mail your renewal to the office by detaching the renewal form on your current license and mailing it with a check, cashier check or money order.

If you send a personal check, please allow two weeks before receiving your new license.

Please make any address changes on the renewal form. Do not send cash for your license. If you pay in person, we accept credit cards or debit cards also.

There is a \$25.00 penalty for renewals after September 1, and a \$25.00 charge for insufficient funds.

Barbershop Managers & Shop Owners It is the responsibility of the barber shop manager and/or owner to make sure all barbers have a current license before being allowed to work. If there is a question about a license being valid, please call the office to verify the name and number.

Change of Address or Name If your address is different from the one on your renewal form, please draw a line thru the old address and write the new address on the renewal form. Please do the same if your last name has changed. If you have moved or are going to move your barber shop you must contact the office for a shop application. **It is important that you send in the renewal portion of your licenses as they contain pertinent information to assist us in renewing your license.**

HOW TO BECOME A MEMBER OF THE BARBER BOARD

There have been a number of changes to the membership of the barber board and many have asked how they might be appointed to the board. Here are the steps necessary to apply for a board position: Go to this web address:

Fill out the form on line. The following information is needed:

1. Social Security Number
2. Educational history
3. Employment history
4. Special interest groups
5. Legal history, citations or issues
6. Military service
7. Qualifications that you feel make you a good candidate for the appointment you are requesting
8. Professional licenses/certificates held

9. Previous appointments or elected positions
10. Three personal references are required with contact information (addresses and phone numbers)

Many of our barbers are still relying on our inspector, Ed Jordan, to collect money for their licenses. That is not in his job classification, and the state does not want the collection of cash to be a priority.
