ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

VS

TRAVIS JOHNSON, D/B/A TNT CONSTRUCTION & HANDYMAN SERVICE OF NWA

ORDER

The Committee voted unanimously that TRAVIS JOHNSON, d/b/a TNT CONSTRUCTION & HANDYMAN SERVICE OF NWA shall pay a civil penalty of \$400.00 per day for 39 days for the violations of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against TRAVIS JOHNSON, d/b/a TNT CONSTRUCTION & HANDYMAN SERVICE OF NWA to prevent him from performing work in violation. TRAVIS JOHNSON, d/b/a TNT CONSTRUCTION & HANDYMAN SERVICE OF NWA shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

The Committee further ordered that a cease and desist order be issued against MATT HENLEY, d/b/a MATT HENLEY CONSTRUCTION, INC to prevent him from performing work in violation. MATT HENLEY, d/b/a MATT HENLEY CONSTRUCTION, INC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

JASON CARL CAPPS, d/b/a CAPPS CONCRETE CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
