

## **FEBRUARY 24, 2021 HEARINGS**

**ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**vs**

**RUSTY FISHER, D/B/A TCB PROTECTIVE COATINGS & HANDYMAN SERVICES**

### **ORDER**

The Committee voted unanimously that RUSTY FISHER, d/b/a TCB PROTECTIVE COATINGS & HANDYMAN SERVICES shall pay a civil penalty of \$400 per day for 2 days of activity for a total of \$800 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against RUSTY FISHER, d/b/a TCB PROTECTIVE COATINGS & HANDYMAN SERVICES to prevent them from performing work in violation. RUSTY FISHER, d/b/a TCB PROTECTIVE COATINGS & HANDYMAN SERVICES shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

### **ORDER**

The Committee voted unanimously that JAIME LARA, d/b/a 5 J CONSTRUCTION shall pay a civil penalty of \$400 per day for 9 days of activity for a total of \$3,600.00 payable to the Committee for violation of Section 17-25-505. This penalty is reduced to \$900.00 if there are no further violations or meritorious complaints for 3 years and he obtains a license within 60 days. JAIME LARA, d/b/a 5 J CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ORDER**

The Committee voted unanimously that MILTON TILLMAN, d/b/a TILLMAN CONCRETE, LLC shall pay a civil penalty of \$400 per day for 4 days of activity for a total of \$1,600 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against MILTON TILLMAN, d/b/a TILLMAN CONCRETE, LLC to prevent them from performing work in violation. MILTON TILLMAN, d/b/a TILLMAN CONCRETE, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**ORDER**

The Committee voted unanimously that TONY PIKE & CLIFFORD BAUMAN, d/b/a TONY & POPS shall pay a civil penalty of \$400 per day for 6 days of activity for a total of \$2,400 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against TONY PIKE & CLIFFORD BAUMAN, d/b/a TONY & POPS to prevent them from performing work in violation. TONY PIKE & CLIFFORD BAUMAN, d/b/a TONY & POPS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**BILLY AMOS, D/B/A IN HOME QUALITY RESTORATION SERVICES**

**ORDER**

The Committee voted unanimously that BILLY AMOS, d/b/a IN HOME QUALITY RESTORATION shall pay a civil penalty of \$64,000 for violation of Section 17-25-505 payable to the Committee. This penalty will be reduced to \$2,000 if he is licensed within 60 days, he returns any homeowner's property, and he pay any judgment obtained by the homeowner. BILLY AMOS, d/b/a IN HOME QUALITY RESTORATION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**CASEY CARPENTER**

**ORDER**

The Committee voted unanimously that CASEY CARPENTER shall pay a civil penalty of \$400 per day for 15 days of activity for a total of \$6,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against CASEY CARPENTER to prevent them from performing work in violation. CASEY CARPENTER shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

**KEITH SMITH**

**ORDER**

The Committee voted unanimously that KEITH SMITH shall pay a civil penalty of \$400 per day for 7 days of activity for a total of \$2,800 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against KEITH SMITH to prevent them from performing work in violation. KEITH SMITH shall refrain from bidding on or performing

work as a residential contractor prior to being licensed with the Residential Contractors Committee.

### **CHRIS HERNANDEZ, D/B/A OZARK PROFESSIONAL INSULATION & PAINT ORDER**

The Committee voted unanimously that CHRIS HERNANDEZ, d/b/a OZARK PROFESSIONAL INSULATION & PAINT shall pay a civil penalty of \$400 per day for 9 days of activity for a total of \$3,600 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against CHRIS HERNANDEZ, d/b/a OZARK PROFESSIONAL INSULATION & PAINT to prevent them from performing work in violation. CHRIS HERNANDEZ, d/b/a OZARK PROFESSIONAL INSULATION & PAINT shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
