ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

VS

DONNIE HUTCHINSON, D/B/A HUTCHINSON CONSTRUCTION

ORDER

The Committee voted unanimously that the license of DONNIE HUTCHINSON, d/b/a HUTCHINSON CONSTRUCTION is revoked for misconduct. DONNIE HUTCHINSON, d/b/a HUTCHINSON CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

VS

HUTCHINSON CONSTRUCTION & SON, INC.

ORDER

The Committee voted unanimously that HUTCHINSON CONSTRUCTION & SON, INC. shall pay a civil penalty of \$400 per day for 247 days of activity for a total of \$98,800 for violation of Section 17-25-505. This amount is to be reduced to \$15,000 provided there are no further violations for 3 years. The penalty is payable to the Committee within twenty (20) days. HUTCHINSON CONSTRUCTION & SON, INC. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

VS

JACOB P. "JAKE" HANSEN

ORDER

The Committee voted unanimously that JACOB P. "JAKE" HANSEN shall pay a civil penalty of \$400.00 per day for 115 days of activity for a total of \$46,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against JACOB P. "JAKE" HANSEN to prevent them from performing work in violation. JACOB P. "JAKE" HANSEN shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

RELIABLE BUILDING INC

ORDER

The Committee voted unanimously that the license of RELIABLE BUILDING INC is revoked for misconduct. RELIABLE BUILDING INC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
