**ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE**

**CORY SILVA, D/B/A C. SILVA'S CONSTRUCTION**

### **ORDER**

The Committee voted unanimously that CORY SILVA, d/b/a C. SILVA'S CONSTRUCTION shall pay a civil penalty of \$400 per day for 50 days for a total of \$20,000 for violation of Section 17-25-505. This amount is reduced to \$1,000 if there are no further violations for 3 years and he pay any judgment obtained by the homeowner and is payable to the Committee within twenty (20) days. CORY SILVA, d/b/a C. SILVA'S CONSTRUCTION shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

### **ORDER**

The Committee voted unanimously that PATRICK WEBB, d/b/a WEBB CONSTRUCTION, LLC shall pay a civil penalty of \$400.00 per day for 195 days of activity for a total of \$78,000 for violation of Section 17-25-505 payable to the Committee within twenty (20) days. The Committee further ordered that a cease and desist order be issued against PATRICK WEBB, d/b/a WEBB CONSTRUCTION, LLC to prevent them from performing work in violation. PATRICK WEBB, d/b/a WEBB CONSTRUCTION, LLC shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

The Committee further ordered that a cease and desist order be issued against DENNIS & MELISSA POWERS, d/b/a POWERS HANDYMAN SERVICES & CUSTOM BUILDS to prevent them from performing work in violation. DENNIS & MELISSA POWERS, d/b/a POWERS HANDYMAN SERVICES & CUSTOM BUILDS shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
