ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

RICHARD NORTINGTON

ORDER

The Committee voted unanimously that Richard Northington shall pay a civil penalty of \$3,650.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ARKANSAS RESIDENTIAL CONTRACTORS COMMITTEE

vs.

CALVIN F. HAMMOND, D/B/A C & C CONSTRUCTION

ORDER

The Committee voted unanimously that the license of Calvin F. Hammond, d/b/a C & C Construction shall be suspended if the complaint in question is not resolved by November 15, 2006. If the complaint is not resolved in this time, the license of Calvin F. Hammond, d/b/a C & C Construction shall remain suspended until such time as he appears before the Residential Contractors Committee.

The Committee voted unanimously that the license of B & H Custom Siding, Inc. is hereby revoked. B & H Custom Siding, Inc. shall refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

ORDER

The Committee voted unanimously that Rich Moore shall pay a civil penalty of \$8,875.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.

BOBBY JOE BRAMLETT

ORDER

The Committee voted unanimously that Bobby Joe Bramlett shall pay a civil penalty of \$1,577.00 for violation of Act 950 payable to the Committee within twenty (20) days and refrain from bidding on or performing work as a residential contractor prior to being licensed with the Residential Contractors Committee.
